Walk-trot only. Open to junior riders in their first two years of showing. Trotting permitted in over fences classes.

## **Rusty Stirrup**

**(Classes 3, 4, 12, 20 & 21)**

Walk-trot only. Open to riders 18 and over in their first two years of showing. Trotting permitted in over fences classes.

## **Novice Rider**

**(Classes 5, 6, 13, 22 & 23)**

Walk-trot-canter. Open to riders/horses that have not won 3 blue ribbons in any show. Fences 2'.

## **Junior Rider**

**(Classes 7, 8, 14, 24 & 25)**

Walk-trot-canter. Open to riders 17 years of age and under. Fences 2'3" - 2'6".

## **Adult Rider**

**(Classes 9, 10, 15, 26 & 27)**

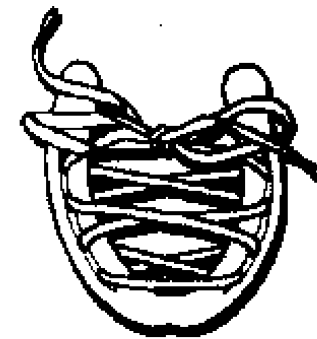
Walk-trot-canter. Open to riders 18 years of age and over. Fences 2'3" - 2'6".
